Welcome Note

Dear Camp Families,

We are excited to welcome you and your camper(s) to Y Summer Camp 2025! This summer, we are thrilled to bring back many of our traditional favorites, while introducing brand new themes and specialty camps across three of our locations: The Natelli Family Y, the Downtown Y and the Y Arts Center.

To ensure a successful and fun experience for you and your camper(s), please take a moment to read through the important details in this email.

**If your camper(s) is also registered for Camp West Mar, be on the lookout for a separate email with more information specific to those locations, which may slightly from what is listed in this email.*

Alaris: New Software for Drop Off, Pick Up & Paperwork

This year, we will be using Alaris for our Camper Health Form & Waiver and to check your camper(s) in and out of camp each day. This software will require only the phone number of the parent/guardian/authorized pickup.

Alaris Account **REQUIRED** for 2025 Y Summer Camp

All campers must have a completed "Frederick County Summer Camp Form" on file through Alaris before attending their first day of Y Summer Camp. **Parent/guardian participation in this platform is required** in order to:

- Complete "Frederick County Summer Camp Form" for each camper(s)
- Add/remove authorized pickups
- Receive weekly and/or daily communications from Camp Leadership regarding camp schedule, severe weather and other important alerts

Creating your Alaris Account

1. Please, watch [THIS HOW-TO VIDEO](#) on how to create your Alaris account before moving on to step 2.
2. Click [HERE](#) to access the portal login. This process is best done on a computer.
3. After creating and accessing your Alaris account, complete the "Frederick County Summer Camp Form" for all children on your account who are registered for camp.

Camp Hours & Schedule

- **Camp Hours:** All camp days run from **9:00 AM to 4:00 PM**.
- **Before and After Camp Care:** We offer extended care from **7:00 AM to 9:00 AM** and **4:00 PM to 6:00 PM**, included in the camp fee.

Weather Policy

Camp will be held **RAIN OR SHINE**, please be sure that your camper dresses appropriately for the weather each day. In the event of extreme weather (such as torrential rain, storms, or extreme heat), camps will move indoors to ensure everyone stays safe and comfortable.

Swimming

Campers will enjoy swimming once per week. Specific swim schedules will be sent out to families the week prior to the start of camp via Alaris.

What to Bring

Each day, please ensure your camper brings a backpack with the following items (**ALL** labeled with first and last name):

- **Water bottle**
- Non-perishable **lunch** (and a morning snack, if desired) - afternoon snack is provided
- **Sunscreen** and **bug repellent**
- **Closed toed shoes must be worn**
- **Any required medication** (must be accompanied by the appropriate forms and handed directly to the Camp Coordinator) - *see below for more information*
- Swim suit and towel (when needed)
- Hat for sun/heat protection (optional)
- Change of clothes (optional - you know your child best!)

What NOT to Bring

For the safety and enjoyment of all campers, **DO NOT bring:**

- Electronics (including cell phones and smartwatches)
- Personal belongings that could get lost or stolen
- Valuables

- **Verify Your Registration:** Be sure to **check your account** to confirm the camps you are currently registered for to avoid any confusion.

Medications

If your camper is bringing any medications with them to camp, there are forms required to be completed for over-the-counter or prescription medications. The forms must be completed **IN FULL by a physician and a parent/guardian** for all medications: over-the-counter or prescription. Forms are linked in the buttons below or can be located on our website at frederickymca.com/camps under "Camp Information".

ALL medications MUST:

- Be in their original container (prescription and over-the-counter)
- Contain pharmacy prescription label (if it is a prescription medication)
- Be turned in directly to the Camp Coordinator (or other med certified staff) with the necessary completed form(s) linked below.
